This is a free event for the public to enjoy and vendors must pay a **\$10 fee to secure their spot**. **All application required materials must be submitted to be considered. Payment is due at time of application approval.**

Set up starting at 3:30pm and tear down to be done by 9:30pm. All supplies, canopies, table, chairs must be self-provided. We ask that all the vendors be ready by 5:00pm and stay until the end of the event. **Parking will be first come first serve**; the park gets very popular during evening summer days. Please arrive early.

PLEASE READ & SIGN UNDERSTANDING RULES BELOW:

- Vendors must be 18 years of age or older.
- Only one business per booth
- Both identification and clear signage with price of products will be visible.
- Pricing and all applicable taxes are the sole responsibility of the vendor. Vendors are responsible for collecting and reporting sales tax.
- Food vendors are required and responsible for obtaining permits required for vending. They must adhere to sanitary procedures as required by Public Health standards.
- No alcohol sales or products allowed by vendors.
- Tent and canopy must be secured and weighted so they can be secured in all weather conditions.
- Booth operators must collect and dispose of their own garbage/recycling. Disposal at the park is not allowed.
- Booth operators may not have amplified music at their booth (Live Music will be present)
- Power will not be available.
- The City has the right to refuse any vendors at their discretion or limit the number of similar types of vendors.
- Bring your own change as needed.
- Parking will be available first come first serve at Angle Lake Park
